The Constables and Douzaine of the above Parish invite the Electors and Ratepayers to meet at the Douzaine Room on Wednesday 30th March 2022 immediately following the Ecclesiastical Meeting already convened for 7-30p.m. to transact the following business: -

1. To approve the Parochial Cemetery Accounts for 2021, which have been duly prepared and are available for inspection up to the Parish Meeting.
2. To elect auditors for the Parochial Cemetery Accounts for 2022.
3. To approve the Constables Accounts for 2021 which have been duly prepared and are available for inspection up to the Parish Meeting.
4. To decide if they are in favour of voting the following amounts to be raised by means of **Owners Rates** in 2022:
